Based on the review of your agency conducted by the Wyoming Department of Health, Behavioral Health Division (Division), we are pleased to announce that your agency has met the requirements of the Rules and Regulations for Substance Abuse Standards, Chapters 1-8 until November 30, 2016, for the following substance use disorder services in Wyoming: Level 0.5 Early Intervention DUI/MIP Education (Adult & Adolescent), Level 1.0 Assessment & Outpatient (Adult & Adolescent), Level 2.1 Intensive Outpatient (Adult & Adolescent). Substance use disorder special populations served, and certified for include: Criminal Justice Population, Adolescent Treatment, Co-occurring Treatment and Women's Specific Treatment Services.

Please notify the Division sixty (60) calendar days in advance of your certification expiration date, **or by September 30, 2016**, of your intent to renew, within the online renewal application system on Information Management for Providers (IMPROV). Applicable certification renewal forms, required to be submitted at the time of renewal, are available on the website: [http://health.wyo.gov/mhsa/certs/renewal\\_certifications.html](http://health.wyo.gov/mhsa/certs/renewal_certifications.html).

The online renewal system will prompt each provider for the specific requirements to be entered for documents electronically submitted for review. The Division will have sixty (60) calendar days to review the supporting documentation and will either approve the certification for one year, or deny the certification at that time. During the sixty (60) day review period, the Division may request additional supporting documentation such as client records through a secure and confidential portal.

Please watch for a system-generated "noreply.wdh" email approximately two months prior to your time of renewal containing a new Provider Validation Number (PVN). The PVN will be used to submit your renewal application in IMPROV. If you do not receive a PVN email, please contact the Division. Please notify the Division of any demographic changes to ensure receipt of timely automated email notifications.
